



### **Major expenses**

Marketing costs included a stand at EMOP XII (Turku, July 2016) as well as marketing brochures and Facebook campaigns for both EMOP and CSBSP7. The total sum spent on marketing related activities during the 2015-2016 reporting period was approximately €1100, depending on currency exchange rates.

Another major expense post relates to the <u>development and use of the SBSP website</u> which amounted to total costs of approximately €2424. It was noted in the last financial report (2013-2014) that SBSP had an outstanding debt for website development, this has now been paid. Annual costs for the website have been on average €220 during this period, once the cost of the website development has been deducted.

### Additional comments to the financial report

#### **OUTSTANDING DEBT**

SBSP currently has no outstanding debt.

#### AREAS OF CONCERN

Financially the society is doing well, but the <u>number of grants to be awarded may need to be adjusted</u> given changes in membership levels. Gaining a complete overview of all the members that have paid their dues has been challenging. This process needs to be improved so that the membership list remains updated and reminders are sent to those with outstanding dues before their names are removed from the list.

The treasurer would therefore like to propose two items for further discussion at the AGM

- A new board position, to be selected by the board, is proposed: 'Membership Officer'. The
  person with this position will have responsibility for maintaining and updating the membership
  lists. This person will be chosen from one of the board members.
- Consideration should be given to <u>issuing invoices to all the registered members</u> when payment
  is required rather than the sending of a reminder email by the SBSP president. This may also be
  beneficial for members that have their membership fee paid for by their employers.
